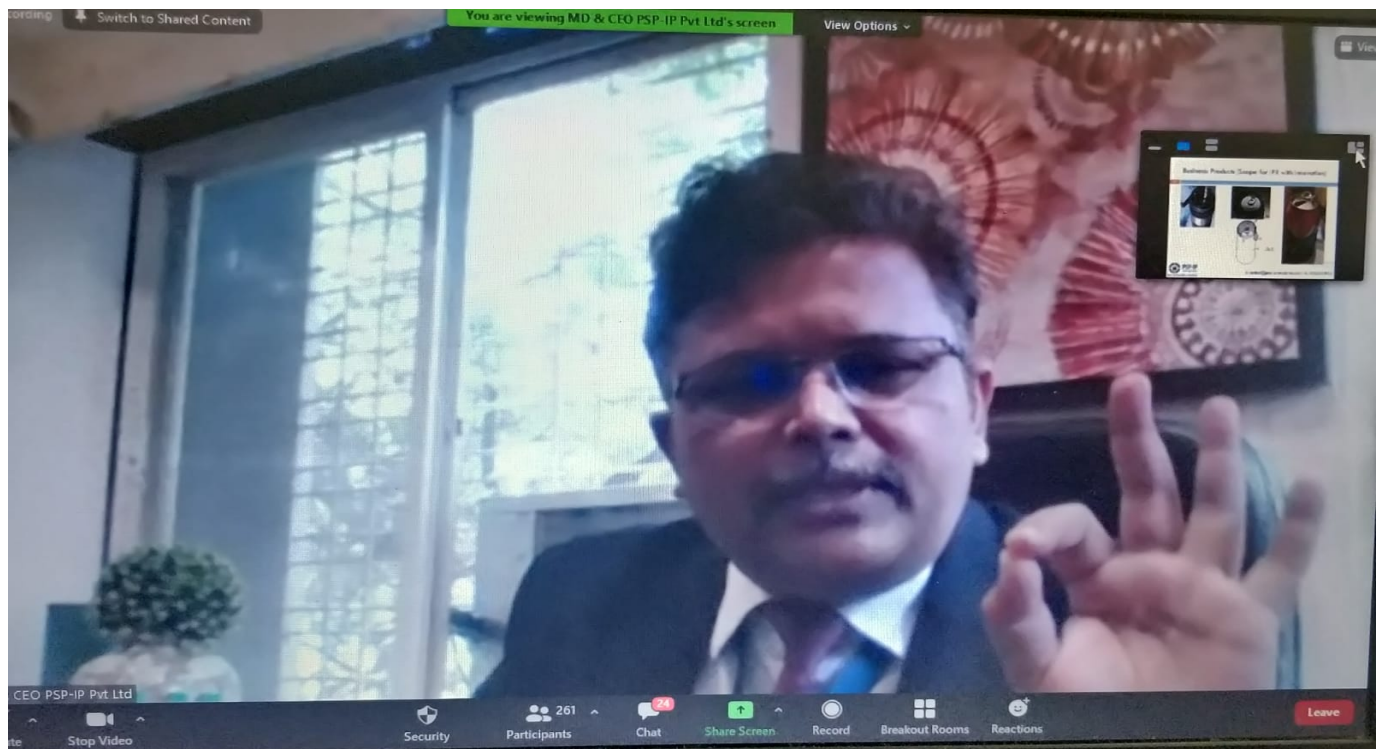

Adv. Dr. Suryakant Patil, a man of great intelligence, shared with us the key to becoming a CEO of a start-up at a young age. He emphasized on the motto “DO MORE, WITH LESS, FOR MORE” as a backbone for start-ups.

He also addressed the Degree faculty in the afternoon session and asked of teachers to be the mentors for the students to present their ideas to the incubation centre and how they can enjoy the perks of patenting at a low-cost investment.
