1. Confirmation of the Minutes of the 7th Meeting of the Academic Council held on 19th April 2023:

The minutes of the 7th meeting of the Academic Council held on 19th April 2023 were read and confirmed.

Resolution: "It was resolved to confirm the Minutes of the 7th meeting held on 19th April 2023".

2. Approval of NEP Framework from the Academic Year 2023 – 2024:

The members were informed about the Major options followed for the different programmes. All Commerce & Arts Programmes are following the DSC option whereas General Sciences are following DSC & Professional programmes in Science are following SSC Option. The members were also shown the framework of few Programmes with DSC & SSC Option.

The Frameworks were approved by the members with some suggestions as follows:

- At TY level a Course of Sustainability should be introduced in every programme.
- ➤ Biostatistics can be introduced in Science Post-Graduation programmes.
- ➤ To introduce Python in the non-technical programmes as multidisciplinary studies.
- ➤ In B.Com programmes, a course related to Logistics can be introduced which would be helpful in pursuing M.Com (E-Commerce).

Resolution: "It was resolved to approve the NEP Framework for UG & PG Programmes to be implemented from the Academic Year 2023-2024."

3. Approval of Skill Courses for SY & TY Commerce & Arts Section for the Academic Year 2023-2024:

The list of Skill Courses for the second & third year of Commerce & Arts Section for the Academic Year 2023-2024 presented before the members was approved with the following suggestion:

The Course 'Start-up India' to be designed in such a way to make it more structural and helpful for everyone with the help of the existing Incubation Centre.

Resolution: "It was resolved to approve the above Skill Courses for the SY & TY of Commerce & Arts Section for the Academic Year 2023-2024."

4. Approval of Additional Division of B.Sc. Biotechnology:

The proposal of an Additional Division for B.Sc. Biotechnology was put forward for the approval of the Council.

The members approved the above proposal. Dr. Majumdar also assured to help with the internship for students in Bio Pharma.

Resolution: "It was resolved to approve the Additional Division of B.Sc. Biotechnology to start with the Academic Year 2023-2024."

5. Revision of Eligibility Criteria for M.Com (E-Commerce):

The proposal of revision of eligibility criteria for M.Com. (E-Commerce) was put forward for the approval of the Council.

- As per the University Ordinance a candidate for being eligible for admission to the Master of E-Commerce Degree Course shall have passed B.Com. Examination of Mumbai University or any other recognized University by U.G.C. and secured not less than 50% marks in aggregate at first attempt (45% in case of reserved category).
- As the College is losing out to many interested students for this Programme due to the above eligibility criteria, has decided to revise the eligibility criteria for M.Com. (E-Commerce) as follows:

'A candidate for being eligible for admission to M.Com. (E-Commerce) Degree Programme shall have completed Graduation in Commerce (B.Com.) or any branches of Commerce (BBI, BFM, BIM, BAF etc.) or in Management Studies from the University of Mumbai or any other statutory University'

Resolution: "It was resolved that the Eligibility Criteria for M.Com. (E-Commerce) be revised from the Academic Year 2023-2024 as 'A candidate for being eligible for admission to M.Com. (E-Commerce) degree Programme shall have completed Graduation in Commerce (B.Com.) or any branches of Commerce (BBI, BFM, BIM, BAF etc.) or in Management Studies from the University of Mumbai or any other Statutory University'."

The meeting ended with a Vote of Thanks to the Chair.
