9. To issue the certificate and diploma to the learners under the scheme of NEP 2020

As per NEP 2020 guidelines, students exiting the First Year programme after securing minimum 40 credits will be awarded UG Certificate in the relevant Discipline /Subject provided they secure additional 4 credits in work based vocational courses or internship / Apprenticeship offered during summer vacation and

Students exiting the Second Year Programme after securing minimum 80 credits will be awarded UG Diploma in the relevant Discipline /Subject provided they secure additional 4 credits in skill based vocational courses offered during summer vacation after first year or second year.

It was suggested to sensitise the students about it as many students leave college & discontinue the education after completing one or two years.

➤ It was suggested to find out the students who have passed and left college & are discontinuing the education after first year under NEP to provide them the Certificate as per the NEP Guidelines.

10. Plan of action for provision of OJT, Internships and CEP under scheme of NEP 2020

The options for On Job Training (OJT) & Internship were discussed.

➤ The Principal suggested approaching students whose parents are industrialists.

The Community Engagement Programme opted by each program in Commerce & Arts Section & Feld Projects by Science Traditional Programs for Sem IV aligned with their Major subjects, placed before the members were approved.
